Minutes

1. Introductions/Welcome

All attendees introduced themselves & AJ thanked all for their attendance

2. Sign up to Terms of Reference and agree Chairperson

All attendees agreed to the terms of reference set out by xoserve and agreed that xoserve would chair the group.

3. xoserve overview and update

RJ talked through a Process Flow Diagram of the xoserve unregistered sites process and the shipperless sites process containing timescales and outcomes. An update on the current position of the USNANA population and the shipper activity population was delivered. AJ informed the group that shipper responses to the unregistered sites shipper reporting had been poor and encouraged all suppliers to respond to these reports to enable swift confirmation of these sites.

4. BG Update

CW discussed the findings of their Project Bounty. 264 Sites were visited as part of project Bounty. From BG's sample a number of potential clerical duplicates were identified. High proportions were identified as occupied premises that were not using gas. The remaining smaller pots were IGT sites, field duplicates and demolished sites.

5. Any Other Business

Synergies with distribution workstreams were identified. Agreement from everyone that joint office should be updated on the formation and progress of the working group.
