1. Introduction and Status Review

1.2 Ofgem Update

In this month's update, DR drew attention to the items relating to:

- Approval of the modified Capacity Methodology Statements including a direction to make some further amendments pursuant to paragraph 8 of Special Licence Condition 9A of the gas transporter licence.
- Introduction of Ofgem's new publications libraries.
- Modification of Special Conditions 1A and 5F of National Grid Gas plc's Gas Transporter Licence to facilitate implementation of the Capacity Allocation Mechanisms (CAM) Network Code.

Attention was also drawn to the recent letter regarding *"Proposed modifications to National Grid Gas plc's Licence to terminate Permit Arrangements and adjust the revenue earned for the period 1 April 2013 – 31 March 2015"*. The statutory consultation on proposed amendments to special conditions of NGGT's licence is open for responses on or before 01 April 2015. Once Ofgem has considered responses, it will aim to make a final decision on whether to implement the reforms during April 2015.

Seeking views on whether it should continue to be produced each month, the Workgroup confirmed it found the Ofgem Update provided very useful and was content for it to continue.

3. Any Other Business

3.1 Capacity Release in Constraints - Update

FH reported that discussions had continued between Market Operations and interested parties to gain a better understanding of the issues. National Grid NTS had concluded that the only way it can assist is in the provision of information where the system is entering into a constraint, and will come forward with some ideas for this at the next Workgroup meeting. FH confirmed that timings and frequency of auctions was not something National Grid NTS intended to look at.

Once EU Capacity Methodology Statements changes are complete, National Grid NTS may look to simplify and reduce complexities in this area; this may include incorporating the Capacity Methodology Statements in the UNC; it may be that capacity release in constraints can be addressed when this is being reviewed.

3.2 Demand Side Response (DSR)

LJ drew attention to the recently issued report on the Draft Gas Demand Side Response Framework and Methodology (published at: www.gasgovernance.co.uk/dsr/090915). Ofgem will review the report and give further direction, following which the DSR Workgroup will reconvene in September to progress as appropriate.

Shippers with large customers were strongly encouraged to consider the report and attend the DSR Workgroup when it reconvenes.
