#### 4.1 Gemini Capacity Release Issue

JD drew attention to a letter issued on 30 July 2014 reporting that a fault had been experienced on the Gemini system, which meant that the quantities of firm capacity released in the day-ahead and within-day entry capacity auctions at Easington, Cheshire and Fleetwood were below the obligated level for a number of days in April and May. The details of the days and quantities affected were given in the tables at the end of the letter. The letter has been published on the Joint Office website:

It was believed that only 3 parties had been affected and they had been contacted. Any other party who believed they might have been affected was encouraged to contact JD.

JD explained the action taken to remedy the position and confirmed that National Grid NTS together with Xoserve was conducting a review to ascertain if there were any further issues and to prevent the occurrence of any similar fault.
