# **Congestion Management Procedures (CMP)**

- CMP is the first of the twelve Network Codes to go live, will occur on the 1st October 2013.
- To facilitate this NG raised UNC0449, introducing:
  - Interconnection Point as a new classification of "System Point"
  - Surrender processes for NTS Entry and Exit Capacity
  - AMSEC Auction Oversubscription
  - Transparency obligations
- UNC0449 implemented 1 October 2013 First use will be the Surrender and Oversubscription processes for the February 2014 AMSEC Auction. Surrender process to be initiated in December 2013.
- Potential overlap with Christmas holiday period. Workgroup views sought on options available.



### **High Level Surrender Process**

Step 1	NG issue surrender invitation / not less than 15 business days prior to AMSEC Invitation
Step 2	Surrender Window Opens / not less than 5 business days after step 1
Step 3	Surrender Window closes / open for 5 consecutive business days
Step 4	AMSEC Auction Invitation Issued / not less than 28 days prior to the first day of the AMSEC Auction
Step 5	AMSEC Auction opens / held on 4 business days / 2 business days between each day
Step 6	AMSEC Auction Closes
Step 7	Unsatisfied bids in Tranche 4 allocated via adhoc Oversubscription and Surrender Auction
Step 8	NG enacts surrenders via Forward Agreements / within 5 business days of adhoc auction closure

# Long Term UIOLI and Day Ahead UIOLI

- Long Term UIOLI;
  - NG will monitor Capacity Entitlements and Capacity Utilisation (at IPs only);
    - Report will be sent to Ofgem twice per year
    - First report due April 2014 (Oct March)
  - not part of UNC Modification 0449
  - NG currently looking to determine whether new UNC Modification is required.
- Firm Day Ahead UIOLI;
  - not required until July 2016
