003TR Review of NTS Exit Capacity Arrangements

- (4112) The afternoon session received a presentation on this from Transco. This session replaced the Exit Reform Forum arranged by Transco for the same time. A further meeting to discuss this Topic may be arranged prior to the Workstream. In this event, at least five working days notice will be given and all presentations for this meeting will be circulated at least two working days in advance
- 004TR Emergency Arrangements
- (PSS/7) Transco would be making a presentation at the June Workstream meeting on Emergency Arrangements following Network Sales. The associated discussion may or may not prompt changes to the UNC Section Q. In addition there are potential changes that may arise at the conclusion of Ofgem's Cash-out Review Working Group. SGD also suggested that Section Q be reviewed to see how the current wording dealt with IS failures. Transco agreed to consider this and respond at the June Workstream meeting.

e.on UK plc requested the creation of this Topic. It believed that a review of ahead-of-the-day and within-day nomination timetable might lead to a Proposal for a more flexible nomination regime. e.on to prepare a presentation for the July Workstream

This would build on the consensus reached in respect of the Supply/Demand planning process that forms the basis of the Transco's Ten Year Statement.
