003TR Review of NTS Exit Capacity Arrangements

The Workstream received a report from Ofgem on the potential implications for Transitional and Enduring Offtake arrangements as a result of Ofgem's Transmission Price Control Review Third Consultation.

004TR Emergency Arrangements

The Workstream received a report from Ofgem on the Gas Safety Reserve Procurement Meeting.

The Workstream agreed that a Modification Proposal that incorporated the proposed simplified and clarified legal text of Section Q (submitted to the March Workstream) would be sufficiently developed to initiate consultation.

008TR Entry Capacity

The Workstream received a further presentation from National Grid NTS on aspects of AMSEC auctions and put forward two suggestions for optimisation of capacity between Aggregate System Entry Points (ASEPs).

National Grid NTS also submitted a draft proposal to bring forward the LTSEC auctions for 2006. It was agreed that a proposal substantially of that form would be sufficiently developed to initiate consultation.
