073 'Revision to the Notice Period regarding the implementation of changes to Transportation Charges'

The Workstream discussed Proposal 073 following on from discussion at the Distribution Workstream on 26 January 2006. Consensus was to recommend to the Modification Panel that the Proposal is sufficiently developed to proceed to consultation. The Workstream also recommended that the Panel should consider shortening the consultation period in order to ensure that, should the Authority so direct, the Proposal could be implemented in time for the Transporters to give four months notice of any changes to transportation charges to be effective from 1 October 2006.
