003TR Review of NTS Exit Capacity Arrangements

Alternatives to Proposal 0116 were raised and are proceeding with Proposal 0116 through consultation. Legal Drafting for Proposal 0116 was reviewed at a Workstream meeting on 25 October and National Grid NTS indicated their intention to provide an early representation putting forward necessary adjustments to the legal drafting. On 2nd November the Workstream received a presentation on Alternative 0116B and an outline of Alternative 0116C. National Grid NTS have signalled their intention in Workstream meetings and subsequently raised a Variation Request for Proposal 0116.

Alternative Proposal 0118A was raised and explained to the Workstream and is proceeding with Proposal 0118 through consultation.
