The Workstream discussed the presentation "Entry Capacity Transfers in the Constrained Period" that outlined the basis of a Modification Proposal for zone based transfers.

The Workstream discussed the presentation "Constraint Management". There was consensus support to strengthen Entry Capacity Overrun incentives and qualified support to restrict the release of relevant unsold entry capacity for days on which a constraint is highly likely.
