# Congestion Management Procedures - CMP

#### **Congestion Management Procedures – Modification Proposal**

- Modification Proposal 0449 raised by NTS
  - Introduction of Interconnection Points and new processes and transparency requirements to facilitate compliance with the EU Congestion Management Procedures'
- Modification UNC0449 completed development through the Tx Workgroup process
  - Representations made unanimously supported implementation
  - August Panel recommended Final Modification Report be implemented
    - With Ofgem for decision.

## **EU Interoperability Code: Current Position**



- The Interoperability Code and an accompanying 'Analysis of Decisions' document\* are currently progressing through ENTSOG's internal governance procedures
- ENTSOG is on track to deliver the draft Code to ACER by its 11<sup>th</sup> September deadline
- ACER's 3 month period to review the Code will then follow
- \* The purpose of this document is to explain the policy options chosen by ENTSOG which are documented in the Code

## Allocations Regime at IPs – a reminder

- At last month's Workgroup, National Grid NTS announced it was interested in GB shipper views on the potential for a new 'allocate as nominate' plus OBA regime for shipper allocations at GB IPs
- (Limited) feedback received so far has been supportive of such a reform to GB arrangements at IPs

Interoperability	ENTSOG is on track to deliver the Interoperability Code plus its 'Analysis of Decisions' document to ACER by its 11th September deadline.	Q4 2015 (Estimated)


