- (a) to secure that the equipment, software and facilities to be installed by it in connection with UK Link are adequately protected against damage and security risks; and
- (b) to implement and maintain at its premises or where applicable its User Agent's premises (in accordance with Section [V2.1.2(d)(i)]) the operational environment required for the operation of the UK Link Network.
- 3.2.3 In accordance with the Part [] of the UK Link Manual, UK Link Users will be classified according to indicators of expected use of and access to UK Link; and the minimum scope and configuration of the equipment, software, facilities and resources from time to time to be provided by a UK Link User in accordance with paragraph 3.1, will be determined (as described in Part [] of the UK Link Manual) by reference to such classification.

3.2.4 For the purposes of this Part B;

- (a) "UK Link User Equipment" is the computer hardware and other equipment from time to time provided by a UK Link User in accordance with paragraph.3.1;
- (b) **"UK Link User Software"** is the software from time to time installed on the UK Link User Equipment in accordance with paragraph.3.1.
- 3.2.5 Except in so far as provided by the <u>CDSP</u> in accordance with paragraph <u>3.3</u> it is the responsibility of each UK Link User to ensure that the UK Link User Equipment and UK Link User Software comply with the specifications and satisfy the configurations described in <u>Part</u> of the UK Link Manual.
- 3.2.6 In accordance with Part [] of the UK Link Manual, a UK Link User must obtain and the <u>CDSP</u> will provide under licence certain of the software required to be installed pursuant to paragraph <u>3.1</u>.
- 3.2.7 Except as provided in paragraph 3.2.6 and as otherwise provided in Part [] of the UK Link Manual, and without prejudice to the requirements of this paragraph 3, UK Link Users may procure from any source any of the equipment, facilities and software required under paragraph 3.1
- 3.2.8 Where Part [] of the UK Link Manual specifies (in addition to what is specified for the purposes of paragraph, 3.1) any benchmark ("Benchmark UK Link Configuration") for the specification, standard or configuration of equipment, software or other facilities to be installed pursuant to paragraph, 3.1;
 - (a) a UK Link User shall not be required to secure that its UK Link User Equipment and UK Link User Software comply with the Benchmark UK Link Configuration (but without prejudice to paragraph 3.1); but
 - (b) a UK Link User who does not secure compliance with the Benchmark UK Link Configuration shall be responsible for satisfying himself and securing that the equipment, software and facilities installed by him are capable of operating in accordance with the requirements of this <u>Part B [and Section U of the Uniform</u> <u>Network Code]</u> and allowing UK Link to function thereon.
- 3.2.9 The Benchmark UK Link Configuration expressly excludes any computer hardware or software whose functions are beyond the scope of what is required (in accordance with paragraph.3.1) for the use of and access to UK Link.

- 3.2.10 The <u>CDSP agrees that it will</u>, in consultation with the UK Link Committee, from time to time review the Benchmark UK Link Configuration in the light of technological developments in the computer hardware and software generally available to <u>UK Link</u> Users with a view to determining whether it would be appropriate (as a UK Link Modification) to modify such configuration.
- 3.2.11 Where Part [] of the UK Link Manual so requires in respect of any UK Link User Equipment [(not including an Active Notification Device)], a UK Link User shall inform the CDSP of the premises at which such UK Link User Equipment is installed and shall not relocate such equipment from such premises except in accordance with the requirements of Part [] of the UK Link Manual.
- 3.2.12 Paragraph <u>3.1</u> is without prejudice to any term referred to in paragraph <u>3.3.4</u> pursuant to which the cost of maintenance of any <u>CDSP</u> Available Equipment is to be borne by the <u>CDSP</u>.

3.3 **CDSP** Available Equipment and Software

- 3.3.1 For the purposes of this <u>Part B</u> "CDSP_Available Equipment" and "CDSP_Available Software" are respectively those items of computer hardware and other equipment, and computer software (excluding that referred to in paragraph <u>3.2.6</u>), which are available to be provided by the <u>CDSP</u> as described in <u>Part []</u> of the UK Link Manual.
- 3.3.2 Upon request by a UK Link User (by notice to the <u>CDSP</u> and otherwise subject to and in accordance with <u>Part</u> of the UK Link Manual), the <u>CDSP</u> will provide on hire any <u>CDSP</u>. Available Equipment and/or supply <u>CDSP</u>. Available Software.
- 3.3.3 The <u>CDSP</u> will not provide (and shall not be deemed to have provided) to a UK Link User any <u>CDSP</u> Available Software except on terms that the <u>CDSP</u> does not license and is not a party to any licence of such software to the UK Link User and that the existence and terms of the licence between the UK Link User and the person entitled to grant such a licence will be as prescribed by such person or as otherwise agreed between such person and the UK Link User.
- 3.3.4 The terms (including without limitation terms as to hire and other charges or fees) upon which the <u>CDSP</u> provides any <u>CDSP</u> Available Equipment or <u>CDSP</u> Available Software, or maintain any <u>CDSP</u> Available Equipment, shall be those set out in the <u>Part</u> <u>]</u> of the UK Link Manual or otherwise agreed between the <u>CDSP</u> and the UK Link User, and do not form part of the <u>DSC</u>; provided that where a UK Link User has not entered into an agreement with the <u>CDSP</u> in respect thereof, it shall be deemed to have agreed to the applicable terms in <u>Part</u> <u>]</u> of the UK Link Manual.
- 3.3.5 UK Link User Equipment (including replacement parts) which is provided by the <u>CDSP shall</u> be deemed to comply with the Benchmark UK Link Configuration.

3.4 Means of telecommunication

The means of telecommunication to be used for the purposes of the UK Link Network, including the telecommunication protocols and requirements as to third party service provider(s) will be as set out in Part [] of the UK Link Manual.

4.5.2 In the event that any of the Licensed Software or any part of UK Link becomes, or in the <u>CSSP's</u> reasonable opinion is likely to become, the subject of a claim for infringement of copyright or any other intellectual property rights owned by a third party, the <u>CDSP may</u> (without prejudice to any other action it may take in respect of such claimed infringement) in accordance with the <u>Change Control Procedures</u> replace or modify that Licensed Software or part of UK Link so as to make it non-infringing

4.6 **Indemnity and liability**

- 4.6.1 Each UK Link User shall indemnify and hold harmless the <u>CDSP</u> from and against any and all loss, liability, damage, claim, action, proceeding, cost and expense resulting from any breach by such UK Link User of paragraphs <u>4.2</u>
- 4.6.2 Where any claim has been made against the <u>CDSP</u> on the basis of facts, events or circumstances which are or may be the subject of the indemnity given under paragraph <u>4.6.1</u> by a UK Link User, and the <u>CDSP</u> would intend to enforce such indemnity in respect of such claim, the <u>UK Link User</u>:
 - (a) if so requested by the <u>CDSP</u>, agrees to provide reasonable assistance, not being financial assistance (but without prejudice to the indemnity itself), to the <u>CDSP</u> in defending the claim;
 - (b) agrees that where it may reasonably be concluded, having regard to the extent to which the <u>CDSP</u> has defended the claim, from a finding of a court of competent jurisdiction against the <u>CDSP</u> that the UK Link User was in breach of paragraph 4.6.1, such breach will be taken to be established by such finding of such court; and
 - (c) acknowledges that there will be circumstances in which it is commercially appropriate that the <u>CDSP</u> should settle or cease to defend such claim, and agrees (if requested) to discuss in good faith with the <u>CDSP</u> such settlement or ceasing to defend, or any other arrangements by which the financial and other burden of continued defence would be borne by the <u>UK</u> Link User.
- 4.6.3 Without prejudice to any other provision of the DSC, the CDSP will not be liable to any UK Link User for or for the consequences of any failure, error or defect in or in the operation or performance of UK Link or any part of UK Link (whether in the software programming or otherwise) [or the availability or non-availability of UK Link.
- 4.6.4 The CDSP shall not be liable in respect of any damage or loss or corruption of any software or data or information contained in a computer system resulting from wilful breach of paragraphs 7.1.1 to 7.1.5 and 7.2(a), to the extent that the breach giving rise thereto occurred as a result of the breach by another UK Link User.
- 4.6.5 Without prejudice to any contractual obligation binding on the CDSP other than under the DSC, the CDSP accepts no responsibility for the accuracy of any communication which is not a Code Communication and is made as a UK Link Communication.

4.7 Authorised representative

4.7.1 Where so specified in Part [] of the UK Link Manual, a UK Link User may only have access to and use of certain parts ("individual access parts") of UK Link by an Authorised Representative.
