## UNC 169: Transfer and Trading of Capacity between ASEPs

Following consideration of the request that modification proposal 169: 'Transfer and Trading of Capacity between ASEPs' follows urgent modification procedures, Ofgem has today agreed to that request.

## Characteristics of urgent modifications

Our view is that, in general, urgent modifications are likely to exhibit at least one of the following characteristics:

- There is a very real likelihood of significant commercial impact upon NGG, industry parties, or customers if modification proposal is not urgent;
- Safety and security of the network is likely to be impacted if a proposed modification is not urgent; and
- The proposal is linked to an imminent date related event.

## Applying these characteristics to UNC 169

In reaching our decision on granting urgent status we have considered the Proposer's justification for urgency. Ofgem considers that this proposal satisfies the criteria for granting urgent status to a modification proposal, as set out in its published guidelines.

1) There is a real likelihood of significant commercial impact upon Gas Transporters, Shippers or Customers if a proposed modification is not urgent;

The Proposer of UNC169 is of the view that it needs to be considered alongside UNC156A since UNC169 is based on UNC156A with a few minor amendments. UNC169 would allow trade and transfer allocations to take place for the November 2007 to March 2008 months, rather than for October 2007 to March 2008. Furthermore, UNC169 allows for greater flexibility regarding the timing of trade and transfer auctions and allocations. It is the proposer's belief that if UNC169 is implemented before this winter it will allow for the trade and transfer of entry capacity between entry points which should reduce the likelihood of gas being stranded offshore due to insufficient capacity being available.

3) The proposal is linked to an imminent date related event

The Proposer of UNC169 suggests that this proposal needs to be implemented in advance of the forthcoming winter period, 1 November 2007 to 31 March 2008.

Ofgem agrees that in these circumstances there is a real likelihood of significant commercial impact upon Gas Transporters, Shippers or Customers if UNC169 is not treated as urgent. Furthermore UNC169 is linked to an imminent date related event for the purposes of this criterion.

Ofgem therefore consents to urgency on the grounds that this proposal meets urgency criteria 1) and 3).
