4. AOB

RH gave a presentation on "OAD Telemetry Requirements for "SOMSA" Exit" explaining that changes in the telemetry arrangements would be necessary to reflect changes in the gas control room structures.

Members agreed that this change was necessary and non-contentious and would support a UNC Proposal to implement this change going direct to consultation. It was pointed out that shippers would not be impacted by implementation of this change.

Members agreed to schedule the next Offtake Committee meeting to take place after the next Offtake Arrangements Workstream. However, if one is not arranged prior to the April 17 Panel meeting, the Committee will meet immediately following the Governance Workstream meeting.
