

Notice of MSEC and DSEC Reserve Prices for Capacity used from 1 October 2009

(Issued 1 July 2009)

National Grid is publishing this notice of revised transmission charges two months in advance of the RMTNTSEC auction of system entry capacity, consistent with our Licence and Uniform Network Code obligations.

Below is an update to Table 2 of the NTS Gas Transportation Charges Statement dated 1 April 2009. (The changes are shown in bold text.)

This change reflects the revised system entry capacity reserve prices. It should be noted that the system entry capacity (RMTNTSEC and DSEC), purchased during September 2009 for use from 1 October 2009, will be subject to the appropriate revised reserve prices. All prices have been calculated using the maximum available quantity of obligated NTS SO Baseline entry capacity levels as specified in the NTS Licence and new supply and demand balancing rules as described in GCM16 'Supply and Demand Balancing Rules and Supply Source Data', which is available on National Grid's website under Gas Charging/Consultations.

National Grid will shortly be publishing a separate notice that will give two months advanced notice of the next auction of Quarterly System Entry Capacity (QSEC) Step Prices along with the revised reserve prices for the AMSEC auctions.
