xoserve will, by 4 July, produce the change section discussed in the User Pays Contract Group and circulate this to meeting attendees in order to ensure the legal drafting correctly interprets what was discussed, seeking comments by 11 July.

xoserve will target a complete redraft of the contract by the end of July, and attendees will be invited to reconvene on 31 July with a view to considering this draft prior to the full contract being issued to the wider industry in early August, seeking comments within 4 weeks.
