1 Summary

Is this a Self-Governance Modification?

The Modification Panel determined that this is a self-governance modification because it is unlikely to have material effect on competition or consumers.

Why Change?

UNC Section G 1.6.18 – 1.6.20 requires Transporters to publish information regarding the manner in which the AQ review is conducted. These reports are commonly referred to as "Mod 81 Reports".

The current drafting of UNC, Section G, Paragraph 1.6.18(a) requires that for each User, in aggregate across all EUCs, the number of successful AQ amendment applications made is reported. Modification 0482 if implemented will require that Mod 81 Reports 1 and 2 are amended to report on effective AQ amendments only. This modification will not affect the solution proposed within Modification 0482 but builds on the changes proposed therein.

Presently AQ reporting does not separate SSP and LSP AQ amendments activity. While Reports 5 and 7 provide information on the effect of AQ amendments in respect of increasing/decreased energy by EUC and reports 6 and 8 on the movement of Meter Points between EUCs however this does not provide enough granular information on the impact of AQ amendment activity against the Current AQ (AQ effective at commencement of Gas Year in which AQ Review Process is performed) and Provisional AQ (Transporter calculated AQ commonly referred to as the T04 position).

Solution

The following changes are proposed to the Mod 81 reports:

- 1. Introduction of an additional report 2 i.e. 2b to report on effect of AQ amendments on the Provisional AQ. The existing Report 2 shows the effect of AQ amendments on the Current AQ only.
- 2. Reports 1 and 2 separate reporting for Smaller Supply Points and Larger Supply Points AQ amendment activity. For Threshold Crossers the market sector will be determined by the Current AQ i.e. the starting position at the commencement of the AQ Review Process.

These changes will be applied to the third release i.e. 1st November reporting. Interim reports issued on 1st August will not be affected and will continue to be issued as currently outlined. These changes will be applied to all releases of the Mod 81 Reports i.e. 1st July, 1st August and 1st November.

Transitional Arrangement

Should this Modification not be implemented prior to the production of the 1st July 14 Mod 81 reports, additional reporting which would have been due for release on 1st July 2014 will now be issued following implementation of this Proposal i.e.1st July 14 additional reports, will be issued on 1st August 14. This transitional arrangement will apply to 2014 Reporting only.

Relevant Objectives

Implementation of this modification will introduce increased granularity and transparency to the information provided to Shippers regarding the impact of AQ amendment activity which occurred within the AQ Review Process. As a consequence of this revised approach to

reporting, the reports produced by Xoserve <u>periodically during the AQ Review process</u> and on 1st November following the completion of the AQ Review process and those presented at the AQ Operational Meeting should be more representative of the impact

of AQ amendment activity by Shippers. The proposed changes to reporting will

produce a more transparent picture of energy movements by LDZ and market sector when compared against the Current AQ and Provisional AQ.

Shippers will not incur any additional operational costs as a result of implementing this modification. However, Xoserve has stated that some costs will be incurred in developing and thereafter running these reports.

Implementation

No implementation date is proposed for this modification. However, it would be desirable if this modification were implemented by 1st <u>July 2014 November 2014</u> to coincide with Mod 81 Reporting <u>initial third</u> release as required within UNC Section G 1.6.20(a).

2 Why Change?

UNC Section G 1.6.18 – 1.6.20 requires Transporters to publish information regarding the manner in which the AQ review is conducted. These reports are commonly referred to as "Mod 81 Reports".

The current drafting of UNC, Section G, Paragraph 1.6.18(a) requires that for each User, in aggregate across all EUCs, the number of successful AQ amendment applications made is reported. Modification 0482 if implemented will require that Mod 81 Reports 1 and 2 are amended to report on effective AQ amendments only. This modification will not affect the solution proposed within Modification 0482 but builds on the changes proposed therein.

At the AQ Operational meeting held by telephone conference on 24th January 2014, AQ experts discussed changes, which could be made to the Mod 81 Reports to improve transparency and therefore enhance reporting of AQ amendments activity by Shippers within the AQ Amendment Window. Presently AQ reporting does not separate SSP and LSP AQ amendments activity. While Reports 5 and 7 provide information on the effect of AQ amendments in respect of increasing/decreased energy by EUC and reports 6 and 8 on the movement of Meter Points between EUCs however this does not provide enough granular information on the impact of AQ amendment activity against the Current AQ (AQ effective at commencement of Gas Year in which AQ Review Process is performed) and Provisional AQ (Transporter calculated AQ commonly referred to as the T04 position).

3 Solution

The following changes are proposed to the Mod 81 reports:

- 1. Introduction of an additional report 2 i.e. 2b to report on effect of AQ amendments on the Provisional AQ. The existing Report 2 shows the effect of AQ amendments on the Current AQ only.
- 2. Reports 1 and 2 separate reporting for Smaller Supply Points and Larger Supply Points AQ amendment activity. For Threshold Crossers the market sector will be determined by the Current AQ i.e. the starting position at commencement of the AQ Review Process.

These changes will be applied to the third release of the Mod 81 Reports i.e. 1st November reporting. For the avoidance of doubt, interim reports issued on 1st July and 1st August will not be affected by implementation of this Modification.

-These changes will be applied to all releases of the Mod 81 Reports i.e. 1st July, 1st August and 1st November.

Transitional Arrangement

Should this Modification not be implemented prior to the production of the 1st July 14 Mod 81 reports, additional reporting which would have been due for release on 1st July 2014 will now be issued following implementation of this Proposal i.e.1st July 14 additional reports, will be issued on 1st August 14. This transitional arrangement will apply to 2014 Reporting only.

User Pays

Classification of the modification as User Pays, or not, and the justification for such classification.

This is a User Pays modification, however it does not amend an existing User Pays service. Costs may be incurred amending the existing reports.

Identification of Users of the service, the proposed split of the recovery between Gas Transporters and Users for User Pays costs and the justification for such view.

Transporters have agreed to waive the User Pays charges applicable to this change.

Proposed charge(s) for application of User Pays charges to Shippers.

Transporters have indicated that costs would be minimal and therefore will be waived.

Proposed charge for inclusion in the Agency Charging Statement (ACS) – to be completed upon receipt of a cost estimate from Xoserve.

Transporters have indicated that would not be recovering the User Pays costs associated with this modification so an ACS wont be published.

As a consequence of this revised approach to reporting, the Mod 81 Reports produced by Xoserve periodically during on 1st November following the completion of the AQ Review process and those presented at the AQ Operational Meeting should be more representative of the impact of AQ amendment activity by Shippers. The proposed changes to reporting will produce a more transparent picture of energy movements by LDZ and market sector when compared against the Current AQ and Provisional AQ.

f) Promotion of efficiency in the implementation and administration of the Code

Implementation of this modification will introduce increased clarity and visibility to the information provided to Shippers regarding AQ amendment activity within the AQ Review Process therefore promoting efficiency in the implementation and administration of the Code.
