# Re: UNC Modification Proposal 0625 - Extension of 4 months to 10 months to transfer non-mandatory sites from Class 1

Thank you for the opportunity to provide representation on the above noted Modification Proposal. Please find below NGN's comments in respect of this Modification.

### NGN does not support this Modification proposal.

## **Reasons for Support/Opposition:**

NGN does not support this modification as we feel sufficient time has been provided to allow for planning of, and undertaking of the transition of voluntary sites from Class 1 to the appropriate Class of 2, 3 or 4; particularly with the original extension of the Daily Metered Service provided by Transporters of Nexus go-live plus 6 months which was approved by Ofgem in February 2015. Shippers indicated in their consultation responses for the original extension modification (0514) that there would be no additional system development or costs associated with the extension that were outside of their already planned Project Nexus costs, as well as confirming support for the proposed timescales. Transporters also highlighted in their responses that they expected prompt action from Shippers regarding the transition and that it should not be left to Transporters to transfer a large volume of sites to Class 4 at the end of the transitional period.

#### Self-Governance Statement:

Do you agree with the Modification Panel's decision that this should be a self-governance modification?

NGN has not changed our position on self governance and voted in favour of this being self governance at the August UNC Modification Panel.

We feel that if this modification were to be approved, it would require Transporters to continue to offer a Daily Metered Service and the associated equipment for sites which do not meet the Class 1 mandatory read criteria instead of these sites moving to meter read providions that have been competitively procured by shippers.

If this modification were approved, we would prefer that it be implemented as soon as reasonably practicable to reduce any further delay in the transitional period.
