
Executive Summary



Key Messages

- Continued to support the ongoing calls to discuss the DM read rejections updates and provide updates on outstanding actions.

DM Read Rejections	We have closed 2 more DM read rejection query over the last week, and there are no longer any Pot 1 queries contributing to the UIG error. We still have 23 meter points from Pot 2 that are impacting UIG and we currently working with shippers to get these resolved. Going forward we will report on number days outstanding to assist shippers with prioritisation.
Erroneous AQs	Data fix applied with effect from 1st December 2017. The enduring fix to ensure no more erroneous AQs are generated where a negative consumption exists in the re-calculation, has been successfully tested and was successfully deployed today 08/12/2017.
CSEP / LDZ Mapping	A further iGT/GT meeting took place to discuss this issue further, Xoserve are continuing to engage with all parties and maintain focus on a prospective correction.
Analyse cause of volatility	Xoserve have continued to use the additional data sets provided by Industry participants in order to enhance the sample size used in analysing the profile modelling. These results will be presented at next week's Demand Estimation Sub Committee (DESC).




