BF welcomed all parties to the meeting and explained that whilst Ofgem has already granted urgent status for UNC Modifications 0642 and 0643, the directed timeline included assessment at workgroup as it was felt that it would be beneficial to the development of both modifications. As a consequence of this process, Alternate UNC Modification 0642A has been raised by E.ON that is currently with awaiting Panel

consideration, although Ofgem might direct that it should be considered as an urgent modification.

BF then confirmed that UNC Modification 0642A is due to be considered at the 18 January 2018 Panel meeting as a 'normal' non urgent modification, although Panel would be asked if the modification should follow the same timeline as directed for Urgent Modification 0624..

BF briefly outlined the proposed timeline for both urgent modifications.¹
