


Existing Process – Provision of Data in Support of CoS



- Data provided to Shipper Users at a Registration Event:
 - Settlement Details
 - Reflection of incoming files (e.g. SOQ / SHQ)
 - Some current incoming data will not be sourced from Shipper files
 e.g. Supplier / CoT
 - Provision of existing UK Link Data (e.g. AQ, FYAQ)
 - Meter Point Data (e.g. Last Inspection Date, Address Data)
 - Organisation Data (e.g. MAM; SMSO... etc)
 - Asset Data
 - Reading Data (e.g. Last Read / Check Read)
- Repetitive Data provided
- Incremental Change approach has led to existing estate

Existing Process – Provision of Data in Support of CoS

- Discussion points for Requirement Definition:
 - Changes will be required to existing record and hierarchy formats
 - Some data will not be driven by Nomination / Confirmation receipt, but by the Supplier / CSS Registration flows (shown earlier) – does this need to be reported separate to existing flows?
 - E.g. Confirmation Response Effective Date / Supplier / (Shipper) / CoT / Market Sector Code (NB: All mandatory currently)
 - Rationalisation of existing data provision?
 - Empty fields?
 - Remove redundancy from within records?
 - Repeatable records e.g. Reading / Organisation / Asset?
 - Others?
