SMu introduced the modification and explained it was seeking to end date the revised estimation process introduced through the implementation of Modification 0634 (Urgent) - Revised estimation process for DM sites with D-7 zero consumption.

DA noted that within Modification 0648S, reference was made in relation to reverting the Legal Text to that prior to Modification 0634 in connection with the timing of 01 June 2018 implementation. BF said implementation was likely to be mid May, following the consultation close out and also noted that Ofgem had been in agreement with the Self-Governance status for this modification. It was agreed that references to the Distribution Workgroup Report on Modification 0634 implementation should be included within the Workgroup Report 0648S to provide clarity and cohesion.
