#### 1.3 Ofgem Update

RD talked the Workgroup through the three decisions that were made by Ofgem during the month of February which covers:

- UNC607: Amendment to Gas Quality NTS Entry Specification at the St Fergus NSMP System Entry Point
- Decision on proposed modifications to Interconnector (UK)'s Charging Methodology.
  - RH asked for a summary of what the changes are relating to the proposed modifications to Interconnector (UK)'s Charging Methodology, RD explained the main changes are tariff network code; limits on multipliers; publication timetable. All details are in the letter published on the link provided in the material.
- Gas system operator incentives 2018 to 2021: Notice to modify National Grid Gas's gas transporter licence

MM confirmed nothing new added this month. The forthcoming Combined ASEP Modification from National Grid is on hold until Modification 0621 is fully developed.

#### **TAR NC: Publication Status**

MM advised that this is a transparency requirement from TAR.

#### **ACER Workshop on TSO Revenue Determination**

MM explained that as part of the Article 34 requirement, ACER are to provide a Revenue Determination for TSOs.

#### **EU Network Codes 'Clean-up'**

The CAM; Balancing; Interruptibility and TAR changes are technical changes only at present.

MM added that if the Clean-up broadens in scope, the timeline might not be possible.

When asked, MM confirmed that the Commission will consult on the proposed changes.
