#### 1.0 Outline of Modification

John Welch (JW) introduced the Modification, explaining that it aimed to add additional reporting requirements to the Performance Assurance Reporting Requirements (PARR) Schedules provided to the Performance Assurance Committee (PAC). The rules established by the implementation of Modification 0520A - Performance Assurance Reporting, (<a href="https://www.gasgovernance.co.uk/0520">https://www.gasgovernance.co.uk/0520</a>), require a Modification to be raised to make amendments to the PARR Schedules.

Steve Mulinganie (SM) questioned if the PAC should see any additional un-anonymised data was it really needed and were the safe guards sufficient. As the PAC memberships are now broadening, from 5 Shipper members to 9, is it appropriate for the PAC to view the data, the Administrator will know the identity of the Shipper and therefore the PAC do not need see who the Shipper is.

JW agreed that there is quite a lot of detail around the arrangements that require further clarification within the Modification.

JW will consider the issue raised, this has been added to the agenda for the next PAC meeting.

#### BF summarised:

- The issue is being taken back to the PAC for clarity on the use of data and if it should be anonymised or not. The next PAC is 12 June, and then feedback to this Workgroup.
- More evidence is required from the PAC as to why the data is required.
- Should the PAFA be taking a wider role between Shipper specific performance and the anonymised data to PAC.
- A test of the model is required to assess if the rules are fit for purpose and that a comparison should be made to the EBCC credit rules and then feedback to PAC/PAFA
