#### 1. Introduction and Status Review

# 1.1. Approval of minutes (27 June 2018)

The minutes of the previous meeting were approved.

# 2. Consideration of Amended Modification

John Welch (JW) advised that the objective for the meeting is to see how far the modification can be progressed and confirmed that the original ROM requires updating as that was based on the previous version of the modification.

JW presented a change marked version of the modification (which can be viewed here: <u>https://www.gasgovernance.co.uk/0652/</u>) and explained the amendments, which mostly are as follows:

- Title change: as this is now changing more to a suite of reports and additional obligations, the new title should reflect this.
- Timeline has changed to report to UNC Panel in September.
- Amendments have been made, mostly based on what was discussed at the last meeting which includes a slight amendment to Section 5 to highlight the suite of reports and current obligations
- There will be a number of industry reports which are listed under the Business Rules heading in the Solution.
- There is an additional obligation to be added in to Uniform Network Code (UNC) which will facilitate sites where there is no winter consumption because there are no winter reads submitted, the obligation will be to take action in September.
- When asked JW confirmed his preference would be not to anonymise the reports, he will make this clearer in the modification.
- JW will also put some narrative evidence in to the modification to explain some of the decisions around anonymity.
- For clarity, it was explained that there will be:
  - Reports for Users they will get their own reports
  - Reports for PAC non-anonymised
  - Reports for Industry anonymised

# 3. Review of ROM

Fiona Cottam (FC) advised that a formal request, from Joint Office, is required for an updated ROM as the ROM request was for the previous version of the modification.

It was clarified that when a modifications content has changed significantly, and there is a noticeable change to the solution, then a new ROM request should be made to Xoserve via email by Joint Office.

#### New Action 0701: Joint Office to request an updated ROM.

Louise Hellyer (LH) asked if, waiting for the updated modification, will have an effect on the timescales to fulfil reporting to the UNC Panel.

Emma Smith (ES) clarified that the SLA to produce a ROM is 10 days, so the timescales will not be affected.

BF also clarified at this point that an Interim report to request more time will be presented to the August UNC Panel.

When asked FC clarified that the amendments to the modification are not changing any of the processes for submitting reads, stronger obligations are being set and a suite of reports at key milestones.
