Section 1: In Scope

To carry out a Feasibility and Analysis (F&A) of the list of Gemini Enhancements. The F&A aims to understand the requirement in more detail and then identify possible solutions.

The duration of the F&A will be a minimum of 5 weeks and no greater than 7 weeks. This is based on the list of 32 items (subject to additional SOx reporting requirements raised by NG and a requirement to deliver additional functionalty for managing energy mismatches, raised by Xoserve) provided to Xoserve. All 32 items are to be taken forward into the F&A.

The output of the F&A is to include:

- A Change Business requirements and Solution options (CBRS) document capturing the requirements and identified solution options
- .Proposals for delivering the solution options including estimated costs and timescales
- Indication of which, if any, requirements can be delivered via the Gemini Replatforming project or other in-flight projects.
- Indicative costs
- Indicative project delivery plan with implementation date proposals.

In addition to the F&A, Xoserve will host a requirements gathering event in relation to Gemini training provisions. This will be open to all Gemini users. The output from the event will be used to formulate proposals for delivery including estimated costs and timescales.

Section 2: Out of Scope

The delivery of any system changes is out of scope. The delivery of revised Gemini training materials is out of scope as the requirements are still being defined. Gemini training materials will be investigated via a different route.
