1. Introduction and Status Review

1.1. Approval of Minutes (02 August 2018)

The minutes from the previous meeting were approved.

2. Consider Amended Modification

2.1. UNC 0662: Revenue Recovery at Combined ASEPs Presentation

CH provided a brief overview of the National Grid NTS 'UNC 0662: Revenue Recovery at Combined ASEPs' presentation, during which he advised that this subject matter potentially involves a small material impact.

With attention focusing initially on the 'Aggregate Entry Flows' slide, a discussion centred on the provided tabulated information during which CH confirmed that the 6% per annum value represents a 'global value'. When asked, CH confirmed that he would look to provide more detailed information relating to these (global) figures at the next Workgroup meeting.

Discussions then moved on to considering the 'Mod UNC 0662: Revenue Recovery at Combined ASEPs' slide, whereupon CH advised that he believed that as far as the 'booked' capacity aspects are concerned, these are the maximum value that it could ever reach, although he would look to provide additional (public arena) information in due course.

2.2. Draft Proposed Amendments to Version 1.0 of the Modification

CH provided a brief outline of the proposed changes (that align with the presentation discussed under item 2.1 above) to the current published version of the modification (v1.0, dated 12 June 2018), during which discussions focused on the following key points:

Section 1 – Summary

CH explained the rationale behind the proposed changes.

When BR enquired whether or not the Forecast Capacity Methodology allows for identification of abandoned capacity aspects and schemes, RH pointed out that work on this area is due to commence shortly.

Section 5 – Solution

CH explained that these proposed changes are looking to better clarify the scope of the proposal.

RH enquired whether or not the Joint Office should prepare a draft Workgroup Report (WGR), subject to formal submission of the amended modification after this Workgroup meeting, to which CH responded by suggesting that he needs a bit more time in order to undertake some additional analysis related to the global 6% aspects before he can then submit the amended modification.

When it was suggested that the modification should also look to take into account 'netting off' for FCC purposes, NW suggested that this is already covered by historical aspects (i.e. the issue of whether booked storage capacity needs to be 'netted off' from the FCC, on the grounds that it is historical capacity, is already catered for as the 'capacity model' already 'nets' off the capacity) – it was requested that National Grid looks to confirm the position at the next Workgroup meeting.

CH then explained that any system related aspects are already covered under the proposed 0621 system solution, with capability being built in to either switch these on/off depending on the outcome of the Ofgem decision on Modification 0621 and its alternatives. The system changes required for Modification 0662 could potentially be included within the October 2019 Release; testing is currently underway.

New Action 0901: National Grid NTS (CH) to confirm whether booked storage capacity needs to be 'netted off' from the FCC, on the grounds that it is historical capacity, and therefor and is already catered for as the 'capacity model' already 'nets' off the capacity.

When asked if there is any information that he would welcome being provided in order to assist progression of the modification, CH responded by suggesting that any supporting financial information would be extremely valuable and helpful.

In concluding discussions, CH pointed out that subject to a decision on any of the suite of 0621 modifications, this modification (0662) maybe withdrawn at some future point.

3. Review of Issues and Questions from Panel

RH explained that these would be considered during subsequent development of the Workgroup Report in due course.
