1. Introduction and Status Review

BF explained that at the 20 September 2018 Panel meeting, Members had requested that a further meeting should be undertaken in order to allow participants a chance to finalise the Workgroup Report.

1.1. Approval of Minutes (27 September 2018)

The minutes from the previous meeting were approved.

2. Consideration for Completion of the Request Workgroup Report

Opening the discussions, CW outlined a potential approach following the 20 September 2018 Panel decision to send back Request 0630R to the Workgroup for further assessment. He went on to explain that legal representatives and Ofgem have already commenced work on the legal text associated with the Retail Energy Code and Faster Switching SCR. At the same time engagement with Xoserve has also taken place in order to understand the potential scale of any systems related work, including trying to establish an initial view for any UNC related or consequential impacts.

CW went on to advise that any new UNC arrangements / requirements would be identified via the appropriate industry engagement mechanisms. The next step in the process involves meeting with Ofgem on 09 October 2018 to try to gain a better understanding of the potential UNC aspects, whereupon primary feedback to the UNC would be via this Request Workgroup.

As the Proposer of Request 0630R, CW is keen to keep this Request open to ensure consequential changes were understood. He also noted that the legal text provision target for the related UNC changes would be circa March 2019, with the UNC update being undertaken during 2021.

When KD enquired as to whether or not the IGT UNC would have similar impacts and have they been engaged in the discussions on this matter, CW pointed out that that there are likely to be impacts that would need to be addressed. However, he remains of the view that the IGTs would need to take responsibility for any IGT UNC related changes.

RC advised that she had discussed these matters with Jon Dixon (Ofgem) at the recent Panel meeting and that he believes that any IGT related impacts would be small – Ofgem will be attending the next IGT Panel meeting in order to discuss these matters further.

In noting that the Panel has requested completion of the Request Workgroup Report (0630R) by the 18 October 2018 meeting, BF suggested Workgroup should seek a further extension in order to consider the additional consequential change information following the Transporter/Ofgem meeting and that this should be open to a joint UNC / IGT Workgroup going forwards.¹

3. Next Steps

The Workgroup to seek an extension through to March 2019 in order to have sufficient time to better understand the consequential impacts on processes due to the Switching Programme and what changes to the UNC would be needed as a consequence. As such impacts are not likely to be identified until later in the year, as the Switching Programme develops, it is suggested that further Workgroup meetings should be arranged once the impacts have been clarified. The Workgroup also notes that such changes would need to be assessed and legal text produced by March 2019.
