1. Introduction and Status Review

1.1. Approval of Minutes (22 November 2018)

The minutes from the previous meeting were approved.

2. Consideration of Amended Modification

Not discussed.

3. Consideration of Legal Text

Ellie Rogers (ER) explained that Legal Text had been provided for the modification which the Proposer is happy that it meets the intent of the proposals.

Bob Fletcher (BF) stated that there are some anomalies in relation to the numbering between the published UNC and the Legal Text for UNC 0668S due to outstanding changes arising from the recent implementation of UNC 0649 *Update to UNC to formalise the Data Permissions Matrix*, as UNC 0668S Legal Text has been written assuming UNC 0649 has been implemented.

A number of minor changes were suggested by Workgroup participants, including:

- The spelling of the word 'not-withstanding' which should be 'notwithstanding'
- Whether 'User type' should be upper or lower case it is upper case in UNC 0649
- A reminder that the preceding paragraph needs to end with the word 'and'.

BF stated that legal text commentary has been requested from SGN.

4. Development of Workgroup Report

BF finalised the Workgroup Report following a brief re-consideration of the impacts and other considerations to make sure that no new considerations needed to be included.

He also confirmed that IGT UNC Modification 116 *Enabling permissions for the provision of information to Alt Han Company to support smart metering roll-out* has been published. Rachel Clarke (RC) confirmed that she did not have any additional comments for inclusion in the Workgroup Report.

5. Review of Outstanding Actions

There were no outstanding actions.

Next Steps

BF confirmed that the Workgroup Report would be discussed at the UNC Modification Panel meeting on 20 December 2018. This would be less than the normal 15-day consultation period.
