As you will be aware, Ofgem granted an extension for Modification 0678 on Friday 08 March 2019.

Within their letter, Ofgem stated that **National Grid** should provide the information listed below **by Friday 15 March 2019.**

- "1. Publish a fully detailed FCC Methodology Statement. NGG should also include a note explaining the governance framework for the FCC methodology
- 2. Publish the final UNC678 Modification and full accompanying analysis
- 3. Publish legal text for UNC678
- 4. Make the Sensitivity Tool on UNC678 available to other proposers. We expect to NGG to make reasonable efforts to support other proposers in using this tool
- 5. A review of Existing Contracts, in line with the views set out in our UNC621 decision letter. This should include analysis on price differentials and set out options in terms of compliance and proportionality."

Ofgem also highlighted the need for **Proposers** "to provide any information and relevant documents to Joint Office **by close of play on 21 March 2019."** Further, Ofgem stated that "Proposers must engage with the JO to ensure that these prerequisites are satisfied ahead of the first workgroup."

Therefore, the Joint Office would be most grateful if you could provide confirmation by **Friday 15 March 2019** (this assumes National Grid have provided all the required data as outlined by Ofgem) as to when you will be providing the following documentation to the team (please note adherence to the timescales provided above).
