#### 2.0 Amended Modification

Louise Hellyar (LH) confirmed this Modification will report to UNC Panel in November 2019 and that the Modification has not been amended to reflect previous discussion.

She advised that discussions have commenced to see what the consequences of the Proposal could be on the Must Read process. It was explained that it is not the intention of this Proposal to increase the number of Must Reads and that clarification will go into the Modification as an amendment.

Andy Clasper (AC) suggested that Xoserve have the ability to filter out all SMART and AMR readings and stressed that Cadent would not want to see 7 million read requests and undertake the filtering themselves. The Workgroup agreed that the Business Rules would need to reflect this.

It was agreed that LH will need to discuss with Xoserve as to whether or not these revised reporting requirements can be met.

GE said that there is a lot of value trying to obtain a read regardless of the value of that read.
