1. Introduction and Status Review

The meeting was confirmed to be quorate.

1.1. Approval of Minutes (12 December and 21 January 2020)

The minutes from the previous meetings were approved.

2. Consideration of Amended Modification and Legal Text

Mark Bellman (MB) asked for feedback on the draft Modification provided for Workgroup consideration on 20 February and suggested discussions are deferred until the March meeting.

Andy Clasper (AC) confirmed that legal text and text commentary had been provided in December and reviewed within the December Workgroup meeting. AC believed the recent suggested Modification amendments did not require additional legal text.

MB reiterated his request for additional feedback on the draft Modification with the intention of submitting a formal Modification amendment ahead of the next meeting to allow the Workgroup Report to be finalised.

It was anticipated that the Workgroup Report would be concluded at the March meeting and submitted to Panel in April.

The Workgroup did not require an extension to the current timeline.

Update: AC confirmed this had been included within the amendment and no additional legal text was required. **Closed.**

Action 1203: Scottish Power (SC) to reference within Section 3 of the Modification as to where the PARR Reports are located presently to aid understanding and clarity.

Update: MB confirmed he will check that this has been included. Carried forward.

Action 1204: Joint Office (RH) to request an extension until March 2020 at the December Panel.

Update: Loraine O'Shaughnessy (LOS) confirmed that the Workgroup Reporting date had been extended to 16 April 2020. **Closed.**
