### 1. Introduction and Status Review

#### 1.1. Approval of Minutes (17 March 2020)

**Update:** ER confirmed the new process flow diagram had been produced and was now published on the Joint Office Website and so this action could now be closed. **Closed.** 

**Action 0301:** British Gas RK to provide v9.0 of the amended Modification at least 5 days prior to the next meeting on 21 April 2020.

**Update:** RK confirmed the amended Modification v9.0 had been provided and so this action could be closed. **Closed.** 

Action 0302: Joint Office, LOS to request an extension from Panel until June 2020.

**Update:** LOS confirmed the extension had been confirmed for June Panel submission and so this action could now be closed. **Closed** 

#### 2. Review Final Amendments to Modification v9.0

Loraine O'Shaughnessy (LOS) confirmed the formally amended Modification Version v9.0 had been provided and was published on the main Modification page. David Mitchell (DM) said that he was still in the process of digesting the content of the amended Modification from a Legal Text perspective. He added that he wanted more clarity with regards to Business Rule 2: As per existing code requirements – the Class 1 Meter Read Requirements should be met "as soon as reasonably practical" by the Transporter. Shippers should cooperate in all necessary steps to facilitate the installation of Daily Read Equipment.

A brief general discussion took place and David Addison (DA) and Ellie Rogers (ER) explained that this area was already included in the Code from an obligations perspective and Rhys Kealley (RK) also confirmed that no additional Legal Text was required. DM confirmed ihe was happy that this area had already been addressed.

## 3. Consider required amendments to Legal Text

David Mitchell (DM) confirmed that he would now progress with the Legal Text ready for discussion at the next meeting on 19 May 2020.

#### 4. Development of Workgroup Report

LOS provided an overview of the tracked changed version of the Workgroup Report and drew attention to specific areas of interest. With regards to the SCR Impact and Other Consideration section, it was assumed there were no impacts and DM said that in relation to Modification 0708 - Re-ordering of the UNC in advance of Faster Switching, that due diligence would be required in finalising the legal text..

RH said that with regards to the implementation section he had amended this slightly within the Modification v9.0, (which had also been transposed into the Workgroup Report) to encompass the COVID-19 element as detailed:

"After a Modification Panel decision to implement (subject to no Appeal being raised) the CDSP would need to confirm the delivery timescales for the changes to processes and systems subject to approval by the DSC Change Management Committee. In determining the implementation timescale, the impacts of COVID19 should be considered in terms of the restrictions on the site visits required to install metering equipment.

A Change Proposal has been raised (XRN 5038) to ensure requirements are captured and assessed."

LOS said she would now proceed to work further on the Workgroup Report in readiness for the May meeting.

## 5. Next Steps

LOS confirmed with Workgroup that the amended Modification v9.0 reviewed was now the final version and that the Legal Text would now be produced for the meeting on 19 May 2020. Workgroup agreed. LOS advised it was her aspiration to finalise the Workgroup Report in readiness for the June Panel 2020 during this meeting.
