**AMENDMENTS TO GAS TRANSMISSION CHARGING REGIME – CONDITIONAL NTS CAPACITY  
CHARGE DISCOUNT**

**LEGAL TEXT CHANGES TO UNIFORM NETWORK CODE**

**Transportation Principal Document**

**TPD Section B: System Use and Capacity**

*In TPD Section B2.11.2, insert ", subject to paragraph 8," after "will be determined".*

*In TPD Section B3.12.3, insert ", subject to paragraph 8," after "will be determined".*

*Insert a new TPD Section B8 in the form in Annex A:*

**TPD Section G: Supply Points**

*In TPD Section G2.3.2, insert a new paragraph (h) as follows:*

*"(h) if the Supply Point is an Eligible Exit Point and the User wishes to make a CNTCD Election in respect of such Supply Point, the Nominated Exit Point and the Nominated Entry Point."*

*Delete TPD Section G2.3.9(a) and replace with the following:*

*"(a) makes a CNTCD Election (in accordance with paragraph 2.3.2(g)) in respect of a Supply Point, and the CDSP does not have available to it the relevant Straight Line Distance, then the CDSP will request such information from the Transporter;"*

*In TPD Section G2.4.2(l), amend to read "paragraph 2.3.2(g) or 2.3.9(h):".*

*Delete TPD Section G2.4.2(l)(i) and replace with the following:*

*"(i) the relevant Straight Line Distance, the six figure grid references, the capacity of the Proposed Supply Point and the CNCC Discount;"*

*In TPD Section G2.5.8(b), insert a new paragraph (iii) as follows:*

*"(iii) where the Supply Point Confirmation relates to a CNTCD Election the proposed Supply Point Registration Date shall not be less than 5 nor more than 30 Supply Point Systems Business Days; and"*

*In TPD Annex G-1, paragraph 10, insert a new final row of the table as follows:*

<i>Making or terminating a CNTCD Election</i>	<i>User specifies</i>	<i>5 Supply Point Systems Business Days</i>	<i>30 Supply Point Systems Business Days</i>

**TPD Section Y: Charging Methodologies**

*In Part A-1 of TPD Section Y, paragraph 1.9.1, insert "(subject to paragraph 5.1.3)" between "rounded" and "to".*

*In Part A-1 of TPD Section Y2.4.3, insert the following new paragraph (iii), and re-number the following paragraphs accordingly:*

"(iii) on the basis of such assumption as National Grid NTS considers appropriate as to the extent to which Users elect for the Conditional NTS Transportation Charge Discount (as provided in paragraph 5)."

In Part A-1 of TPD Section Y, paragraph 4.7.3, amend the formula to read as follows:

$$GNTSC_y = (NANTSR_y / FANQ_y) * SF_y$$

and insert the following definition of "SF<sub>y</sub>" at the end of paragraph 4.7.3:

"SF<sub>y</sub> is a scaling factor determined as (NANTSR<sub>y</sub> / EstNTSR<sub>y</sub>)

where "EstNTSR<sub>y</sub> is the aggregate amount of Non-Transmission Services Revenue which National Grid NTS estimates would be earned in the Gas Year by way of General Non-Transmission Service Charges on the same assumption (as to the extent to which Users elect for the Conditional NTS Transportation Charge Discounts) as made for the purposes of paragraph 2.4.3(iii)."

In Part A-1 of TPD Section Y, insert a new Section 5 in the form in Annex B.

## **Transition Document**

### **TDIIC – Transitional Rules**

Amend paragraph 25.1.1 by adding at the end "and Code Modification 0728D.

Insert new paragraph 25.6 as follows:

#### **25.6 Code Modification 0728D**

25.6.1 The Implementation Date of Code Modification 0728D shall be 1 October 2020 or such later date (being the first calendar day of a month) as the Authority shall direct when it directs that Code Modification to be made.

25.6.2 If the date on which the Authority directs that Code Modification 0728D is made is between 1 October 2020 and 1 September 2021, Section Y2.4.3(iii) (inserted by that Code Modification) shall not apply in respect of any remaining months within the Gas Year commencing 1 October 2020.

25.6.2 For the purposes of TPD Section B8 (as introduced by Modification 0728D) a User may make a CNTCD Election:

- (a) no earlier than the date (as notified to Users by National Grid NTS) from which UK Link is modified to implement that Code Modification;
- (b) which is effective no earlier than the Implementation Date of that Code Modification."
