203.5 AOB

a) Consider UNC Data Dictionary Update

RHi introduced the topic by confirming that National Grid is aiming towards an evolutionary path towards the Energy Data Task Force recommendations. The UNC Data Dictionary details the data items available through the National Grid Gas website, specifically, the data item explorer, the report explorer and MIPI. Various tasks to improve the data quality within the UNC Data Dictionary have been undertaken by National Grid (for details please see presentation: https://www.gasgovernance.co.uk/uncc/170920. The changes are highlighted within the UNC Data Dictionary in red. She also outlined the changes to UNC Operations Reporting Manual (UNCORM) which could be classified as housekeeping updates. RHi asked UNCC for their views on the plan to issue out the updated UNC Data Dictionary via Joint Office for an informal National Grid -led consultation for 2 weeks, allowing subsequent approval of the new UNC Data Dictionary to be sought at the October UNCC. She confirmed that the plan, though not the documents itself had already been outlined at UNC Transmission Workgroup and The Gas Ops Forum.

TS requested a longer consultation period; RHi agreed to consider this. RH suggested there could be an opportunity for RHi to answer questions at Transmission Workgroup on 01 October. RHi agreed this would be helpful.

UNCC Members agreed to the plan. Approval of the updated UNC Data Dictionary will be sought at the October UNCC meeting on 15 October 2020.
