1 Summary

What

The UNC Modification Rules currently require that meetings of the UNC Modification Panel take place in London unless the Panel determines otherwise in respect of any meeting. Such a determination would be made by Panel Majority.

This rule has been in place (and has remained unchanged) from the first incarnation of the British Gas TransCo Network Code (01 March 1996) and was subsequently carried forward into the first version of the Uniform Network Code (01 May 2005).

Why

The advent of more flexible working arrangements for individuals and a wider geographical spread of individuals' work locations means that the need for meetings of the UNC Modification Panel to take place in London (and by exception elsewhere) is an unnecessary constraint on the Panel Members and the Code Administrator of the UNC.

Removal of the existing constraints on the location of Modification Panel meetings will provide the Code Administrator with a greater level of flexibility in the arrangement of such meetings thereby optimising costs whilst maintaining the capability of the Modification Panel to fulfil its obligations under the Modification Rules.

How

It is proposed that the requirement for meetings of the UNC Modification Panel to take place in London is removed. Alternatively, it is proposed that meetings of the Modification Panel take place in the location in Great Britain specified by the Code Administrator unless the Modification Panel determines otherwise (i.e. that the meeting take place in a location other than that specified by the Code Administrator). Regarding communication of the meeting location, it is proposed that wherever practical, the Code Administrator provide a minimum notice period of 3 months.

2 Governance

Justification for Self-Governance

Application of Self-Governance procedures is sought because the change proposed is unlikely to have a material effect on the Uniform Network Code governance procedures (nor any of the other aspects described in the Self-Governance criteria). This is because the nature of the change is to merely allow a greater level of flexibility in the location of meetings of the Modification Panel.

Requested Next Steps

This Modification should:

- be considered a non-material change and subject to Self-Governance.
- be assessed by a Workgroup.

It is recommended that the Proposal is issued to the Governance Workgroup for consideration for a period of 2 months. A pre-Modification discussion took place at the Governance Workgroup on 04 August 2021.

3 Why Change?

The UNC Modification Rules Section 5.7.1 currently requires that meetings of the UNC Modification Panel take place in London unless the Panel determines otherwise in respect of any meeting. Such a determination would be made by Panel Majority as per Section 5.1.2(a) of the Modification Rules.

This rule has been in place (and has remained unchanged) from the first incarnation of the British Gas TransCo Network Code (01 March 1996) and was subsequently carried forward into the first version of the Uniform Network Code (01 May 2005).

It is understood that the existing constraint on the location of Modification Panel meetings reflected the work locations of the majority of the members of the UNC Modification Panel and other stakeholders in 1996 and the preference for face-to-face meetings, given the levels of video conferencing technology available at that time. However, the advent of more flexible working arrangements for individuals and the wider geographical spread of individuals' work locations means that the need for meetings of the UNC Modification Panel to take place in London (and by exception elsewhere) is an unnecessary constraint on the Code Administrator of the UNC.

Given this, removal of the existing constraints on the location of Modification Panel meetings will provide the Code Administrator with a greater level of flexibility in the arrangement of such meetings, thereby optimising costs whilst maintaining the capability of the Modification Panel to fulfil its obligations under the Modification Rules.

The inclusion of a minimum notice period for communication of the meeting location is proposed in order to enable parties to effectively plan their time and secure the most efficient travel arrangements. Requiring the Code Administrator to, wherever practical, provide this minimum period of notice recognises that in certain exceptional instances it may not be feasible to meet this minimum notice period requirement (for example sudden unavailability of a venue or the management of the governance of Urgent Proposals).

If this change is not made, the Code Administrator will continue to be obliged to make arrangements for meetings of the Modification Panel to take place in London.

If this change is not made, this may result in higher costs than necessary being incurred by the Code Administrator and individual Panel Members (and other stakeholders) compared to those incurred if more locational flexibility is introduced.

5 Solution

It is proposed that the requirement for meetings of the UNC Modification Panel to take place in London is removed. Alternatively, it is proposed that meetings of the Modification Panel take place in Great Britain in the location specified by the Code Administrator unless the Modification Panel determines otherwise (i.e. that the meeting take place in a location other than that specified by the Code Administrator).

For the avoidance of doubt, a Modification Panel determination in this context shall be made by Panel Majority as per the Modification Rules Sections 2.1 and 5.1.2(a).

Regarding communication of the meeting location, it is proposed that wherever practical, the Code Administrator provides a minimum notice period of 3 months.

6 Impacts & Other Considerations

Does this Modification impact a Significant Code Review (SCR) or other significant industry change projects, if so, how?

Consumer Impacts

Minor cost efficiency. Whilst greater efficiencies in the operation of industry governance process may be observed, this is unlikely to have a material impact on consumers. However, any minor cost efficiency may be passed on to consumers via Transporter price control arrangements in the event that code administration costs, over the longer term, are reduced.

Panel Questions

1. Proof of capability around communication technology for each location

Workgroup recognises that this is not a requirement of this Modification, and that technology can only be fully tested during a meeting. However, the workgroup did acknowledge that having technology that has been tested is important.

The Joint Office will be responsible for ensuring the chosen location has the appropriate technology to facilitate Panel meetings, ensuring the relevant testing has taken place.

2. How will hybrid working be reflected in solution

The Joint Office will ensure at least 3 months' notice is provided, chosen locations will have been tested to ensure technology works with hybrid meetings (combination of in person and online). The Panel also have the right to veto a location if it is deemed not suitable.

A Workgroup representative requested that the Joint Office produce an assessment of locations and technology to assure Panel that meetings can be managed from other locations.

Criteria to include but not limited to: sound quality, connectivity, experience/engagement of attendees, visibility of attendees, effectiveness of voting etc.

Any location of any meeting will be assessed using the agreed criteria.

3. Impact of other workgroups

Workgroup agreed that there is currently no restriction in UNC around location of Workgroup meetings and this Modification does not intend to change this. However, the same criteria used to assess the effectiveness of Panel meetings should be expanded to Workgroup/Committee meetings.

The Workgroup agrees that the legal text delivers the intent of the solution.

5 Meetings of the Modification Panel

5.7 Location and form of meetings

Amend paragraph 5.7.1 as follows:

Unless the Modification Panel shall in respect of any meeting of the Modification Panel otherwise determine, meetings of the Modification Panel will take place in London a location in Great Britain specified by the Code Administrator. The Code Administrator shall, wherever practical, provide not less than three months notice of the location of any meeting of the Modification Panel.

10 Consultation

Panel invited representations from interested parties on 21 October 2021. All representations are encompassed within the Appended Representations section at the end of this document.

11 Panel Discussions

Discussion

The Panel Chair summarised that Modification 0776S would remove the requirement for meetings of the UNC Modification Panel to take place in London.

Panel Members considered the representations made noting that implementation was unanimously supported in the 3 representations received.

Panel Members agreed with respondents in that this Modification allows for flexibility in line with the change in panel members' locales, the advance of technology for remote meetings and the more flexible working arrangements available to the Industry as a whole.

Whilst Modifications affecting Modification Rules would normally require Authority Direction, Panel Members confirmed this Modification is suitable for self-governance.

Consideration of the Relevant Objectives

Based on the two factors below, Panel Members agreed that this Proposal should further Relevant Objective f) the promotion of efficiency in the implementation and administration of the Code:

- The inclusion of a standard notice period of three months allows for maximisation of savings in relation to travel arrangements where utilised.
- This Modification removes the constraint of hosting meetings in London and will enhance the ability of the UNC Code Administrator to optimise code administration costs.

Determinations

Panel Members voted unanimously that no new issues were identified as part of consultation.

Panel Members voted unanimously that Modification 0776S does not have an SCR impact.

Panel Members voted unanimously that there are there are no Cross Code Impacts.

Panel Members voted with 14 votes out of 14, (unanimous) and agreed to implement Modification 0776S.


