It was noted that the changes will be publicised and in respect of BBL the changes will be separately consulted on, to comply with its licence.

Anna Shrigley (ASh) wished to note there would be an indirect positive impact for GB consumers which she wished to be captured within the Workgroup report to note there may be an overall market benefit for short-term arbitrage and as a balancing tool.
