#### **1** Introduction

This publication gives Notice of the change in Supplier of Last Resort (SoLR) charge expected to apply from 1 October 2022. This is a result of Ofgem's decision on 16 June 2022 "Decision Letter", for Independent Gas Transporters (IGTs) to pay Gas Distribution Networks (GDNs) directly for the Last Resort Supply Payment (LRSP) costs relating to the customers connected via an IGT network. This document does not override or vary any of the statutory, licence or Network Code obligations upon Southern Gas Networks.

### 2 Supplier of Last Resort Charges

On the 1<sup>st</sup> December 2021 Ofgem<sup>1</sup> confirmed their request to networks to accept SOLR claims after the 31<sup>st</sup> of October. The valid SOLR claims were approved by Ofgem on the 22<sup>nd</sup> December<sup>2</sup>. SGN notified the market of the final transportation charges that would come into force on the 1<sup>st</sup> of April on the 31<sup>st</sup> of January following confirmation of the necessary licence changes on the 28<sup>th</sup> January<sup>3</sup>. The existing charging arrangements raise the issues as to whether or not gas customers connected via an IGT network are charged the same costs as those connected directly to a GDN network.

In March 2022, Ofgem consented to IGTs revising their 2022/23 charges to reflect LRSP costs<sup>4</sup>. The consent was intended to facilitate LRSP cost recovery evenly between gas customers connected directly to a GDN network and those connected via an IGT network. As GDNs had already set their 2022/23 tariffs this would result in an over-collection of SoLR charges from UK gas customers in 2022/23 unless subsequent adjustments were made to GDN tariffs.

In April Ofgem issued an open letter<sup>5</sup> to consult on options for the recovery of LRSP claims from customers connected directly to GDNs and those connected via IGTs.

In June 2022 Ofgem issued their decision to their open letter<sup>6</sup>. The decision was for LRSP payments to continue to be paid directly by GDNs to SoLRs and for these costs recovered by IGTs to be paid direct to GDNs. As this would result in a material over-collection of SoLR revenue in 2022/23 Ofgem set out their intention to consent to GDNs request for an intra-year revision to tariffs in October 2022 to reflect the payments received from IGTs. Ofgem published their consent in July 2022<sup>7</sup>

It is the responsibility of Southern Gas Networks to recover the costs incurred by the SoLR provider and to pass those onto the new Supplier as set out under Standard Special Condition A48 of the transportation licence. Southern Gas Network collects these costs on a volumetric basis as guided by UNC modification 0797. The original SoLR costs impacting 2022/23 charges were £154.6m, as Southern Gas Networks now forecast to recover a portion of costs via IGTs (c.£16m) the SoLR rate for the period October 2022 to March 2023 needs to

reflect this change. SoLR costs are a straight passthrough therefore only reflect the level of costs GDNs need to subsequently pass onto the wider shipper community.
