228.3. Minutes and Actions from the previous meeting

228.4. Review of Actions

10/03: Joint Office (RH) to ensure PAC Terms of Reference (ToR) are updated to reflect the attendance of REC representatives.

Update: RH advised that PAC are currently merging PAC ToR into the new PAFD. **Closed.**

228.5. Matters for the Committee's Attention

a) Alternative Instruction to set the Registration to Live

D Addison (DA) advised of the failure of a number of registrations. As a consequence, the UNCC were being asked to confirm that the CDSP should accept an alternative instruction to set the Registration to Live for Registrations impacted by a Server Shut Down issue. It was also asked if this should be a short-term alternative or a long-term solution.

T Saunders (TS) asked for clarification about accepting messages under the UNC and if by accepting instructions if this would place parties in breach of the Code if the CDSP utilise a message as an instruction. It was understood that the rules allowed the CDSP to accept the messages but further understanding was required of the impacts and potential consequences.

Upon further consideration of the proposed solution the Members did not object to the proposal as it was considered to be a pragmatic solution.

DA confirmed that the CDSP are undertaking a reconciliation and that he will keep the UNCC updated on the progress and conclusion of the issue.

The next meeting will be on 17 November 2022, immediately after the UNC Modification Panel meeting on that date.
