	Adjustment to paragraph 2.3.20	Clarifies that in the case of Erroneous AQ (Read History) the eligible cause is valid if it occurred not only <i>after</i> the Read Date of the AQ Opening Reading used in the most recent calculation of the AQ, but <i>on</i> that Read Date. Considered appropriate because taking into account an erroneous meter read giving rise to the problematic AQ only if it occurs <i>after</i> the Read Date of the AQ Opening Reading would leave open the possibility of a meter read error on that date – frustrating the intention of the modification.
	Adjustment to paragraph 2.3.21	These words reflect that, for an eligible cause to exist, not only must a relevant description of an eligible cause apply to the circumstances at hand, but the eligibility condition(s) applicable to that eligible cause must also be fulfilled.
	New paragraph 2.3.21(d)	Introduction of new eligible cause – Erroneous AQ (Change in Operation and/or Use)
	New paragraph 2.3.21(e)	Introduction of new eligible cause – Erroneous AQ (Read History)
	New paragraph 2.3.22	Sets out list of conditions that must be met for certain eligible causes to be claimed.
	New paragraph 2.3.22(a)	Utilising any eligible cause to submit an AQ value less than 5% different to the current AQ will not be allowed. Evidence of which to be submitted to CDSP pursuant to paragraph 2.3.24(a)(ii)(1) per existing UNC process.
	New paragraph 2.3.22(b)	The former 2.3.24, being the only condition to the use of an eligible cause pre-UNC816, is consolidated here, at 2.3.22(b).

	New paragraph 2.3.22(d)	The User must undertake certain verification and information gathering steps before being able to claim eligible cause Erroneous AQ (Read History). Evidence of which to be submitted to CDSP pursuant to paragraph 2.3.24(a)(ii)(1) per existing UNC process.
	Reordering of sub-paragraphs within paragraph 2.3.25	Consequent to the formerly sole condition on the use of an eligible cause at 2.3.24 now appearing at 2.3.22(b) (alongside the other conditions on use introduced by UNC816), the appropriate cross reference in 2.3.25 is now to 2.3.22. This change allows the paragraphs of 2.3.25 to continue to make cross references to other paragraphs in numerical order.
