April CMS Rebuild Update

Progress to Date

- XRN5556D The Isolation (ISO) and DTL processes went live on 24th April 2023.
 - The implementation was successful and with no defects
 - So far we have had 18 contacts raised, 4 resolved and the remaining are at various stages of investigation
 - To support we have an open bridge call open daily for customers to jump on if they require support
- Two additional child XRNs have been created to support the next two releases, should there be any capacity within these two version releases other processes or functionality will be brought in scope for delivery with the agreement of the Customer Focus Group:
 - XRN5556.e Address Amendments ADD/UNC) and Distribution Network raised Mnumber creations (DMN)
 - XRN5556.f Request for Adjustments (RFA) and Consumption Dispute Query (CDQ)
- We are working with the UKLink Change team to deliver two change proposals that have CMS Rebuild Impacts, these are scheduled for the November UKLink release
 - XRN5604 Shipper Agreed Reads
 - XRN5605 IGT Must Reads

SPI File Submissions

- In November 2022 we received a number of SPI file submissions from Shippers, totalling to **98.6%** of the Supply Point Register.
- This percentage figure equated to 24,642,812 Supply Meter Points.
- Of the 69 Shippers expected to take part, 56 successfully submitted their portfolios via SPI file by 25/11/2022.
- A total of 13 Shippers failed to submit an SPI file before the window closure date. It was acknowledged however that 4 did make an attempt to submit files.

SPO File Outputs

- Following quality assurance validations, the SPO files were issued to the industry on the 02/12/2022.
- A total of 51 SPO files were issued to selected Shippers.
- We have received 19,932 disputes to date.


SPO File Outputs

- The 40 business day window for Shippers closed on 01/02/2023.
- 12772 sites are Shipperless




ISO & DTL Process Update

SEFE Agenda Items

- Length of time taken to create MPRNs for found supplies/found meters (CMS MNC submitted by supplier)
- Length of time taken to resolve Dead to Live queries raised in CMS by suppliers
- Delay re. networks in setting MPRNs to dead after a service disconnection
- Lack of information provided by networks following a meter being found during GSR visit
- Method of notification of MOD425 found assets
- MPRNs being set to dead by networks when they are a DUP of IGT supplies



End User Registration Issues (Wales & West)

End User Registration Issues (Wales & West)

- Customer reporting to DNs that suppliers are refusing to take ownership of 'Shipperless/Unregistered meters', even bigger ones.
- Customers end up having to contact multiple suppliers or we ask them to escalate via Citizens Advice.
- For domestic customers we need to find a solution to overcome issues. If not, we end up with ongoing theft of gas situations and unregistered use of gas.
