### **Review of Process**

Update on actions from last month

- Investigate the potential to reduce the timescales for the Cash Call Notice, Energy Balancing and Further Security Request processes by removing the issue of Failure Notices. The draft Modification Proposal has been reviewed and will be sponsored by GF.
- 2) Mod to give EBCC the power to instruct NTS over appropriate recovery steps. A draft Modification Proposal has been reviewed and will be sponsored by GF.
- 3) Look at processes once termination has been issued with the aim to tighten timescales thereby reducing overall debt.

  JD reported that CRM had attended a seminar and had learnt that it was possible to apply for a winding up petition without issuing a Statutory Demand, which would considerably shorten timescales. Members discussed whether it would be possible to do these two actions in tandem or whether the issue of a Stat Demand would frustrate any application to wind up. Legal advice would be sought.
