Update from Winter Issues Group and Way Forward for EBCC

A number of issues have been considered by the Committee over the last 12 months. Each issue has pointed to the fact that the way forward would be to reach the point where a Supplier of Last Resort could be appointed as soon as possible. To date Ofgem has been reluctant to support any of the proposals made.

The EBCC have offered support to the proposals made by National Grid regarding the current Supply Licence Review. The EBCC will be notified once a response has been made to these proposals.

MC advised the group that the Winter Issues Group are currently looking at how a prospective buyer of the portfolio of a failing User may be able to give an undertaking from a certain date, but prior to transfer of portfolio. They are also seeking to educate and influence key Users who would be likely candidates to pick up the portfolio of a failing User.

It was agreed that a risk register would be developed highlighting the risks that have already been identified by the group, ready for review at the next meeting. The register would be used as a working document.
