MC highlighted UNC 0605S - Amendments to TPD Section K - Additional Methods to Procure and Dispose of Operating Margins Gas, which was raised by National Grid NTS. He confirmed that the modification is being assessment to understand the implications of financial neutrality.

4.2 Calculation Change in Gemini

MC highlighted that following the implementation of a change within Gemini relating to a Calculation Change it had been identified that the IMS calculation had not been updated.

Since identification of the issue additional checks have been added to the process to ensure extra validations are undertaken. MC confirmed that one user had been affected to date.

4.3 Management of non-members observing meetings

CB enquired how the Joint Office will manage parties not dialing out of the DSC Credit Committee and observing the EBCC.
