It was proposed to arrange a Legal Text review meeting in April.</li> <li>• <b>0646R - Review of the Offtake Arrangements Document.</b> The Workgroup reviewed Modification 0683 and proposed OAD and supplemental agreement amendments. It was noted that the Modification 0683 had been submitted for consideration at 21 March Panel. It was anticipated that a further two Modifications would be required to take forward the recommendations from Workgroup 0646R.</li> </ul>	

- **Joint Theft Reporting Group (UNC & SPAA), including 0677R** - the first meeting took place on 01 March 2019. The Terms of Reference and Workplan were agreed at the meeting.
- The main focus of the meeting was to review the theft reporting process information provided by First Utility, Xoserve and ElectraLink. A draft issues log was developed and around 26 issues have been identified. The issues log will form the focus of the next meeting, where the group will aim to identify route causes and potential solution options.

## Transmission Workgroup Headlines [www.gasgovernance.co.uk/tx](http://www.gasgovernance.co.uk/tx)

At the meeting on 07 March the following were discussed/progressed:

- **Pre-Modification discussions**
  - *Amendment of the UNC term 'Gas Deficit Warning' to 'Gas Balancing Notification'* – The Workgroup noted the intent of the draft Modification which was generally supported. It was noted that there might be an impact on the Transporters licence which would need to be considered.
  - *Recovery of Shipper costs during SoLR* – The proposer agreed to consider the comments received prior to submitting the Modification to the April Panel.

At the meeting on 07 March 2019, the following Modifications were discussed/progressed:

- **0667 – Inclusion and Amendment of Entry Incremental Capacity Release NPV test in UNC.** The Workgroup discussed the amended Modification. It was noted that if implemented the Modification would require a change to the Transporters licence. It was agreed to seek a view from Panel prior to concluding the Workgroup Report for April Panel.
- **0669R - Review of the Gas Deficit Warning (GDW) and Margins Notice (MN) Arrangements.** The Workgroup considered the presentation and the impacts on the Margins notice trigger. The view was to conclude the Workgroup Report at the next meeting.
- **0671 – Relief from User Commitment obligations when NTS exit capacity substitution is permitted.** The Workgroup discussed the Modification and associated ROM. It was agreed to review an amended Modification at the next meeting.
- **0675S – Enabling changes to the BBL Interconnection Agreement to facilitate physical reverse flow.** No further progress was made with this Modification and it was agreed to seek an extension to the Panel reporting date.
- **0680S - UNC Changes as a Consequence of 'no deal' United Kingdom Exit from the European Union.** The Workgroup noted the proposed changes should the UK leave the EU without a deal. Following review of the Solution and Legal text the Workgroup Report was concluded for submission to the 21 March Panel.

## Charging Methodology Forums

### Distribution Network Charging Methodology Forum (DNCFM)

- The next quarterly DN Revenue reports were published in December and were reviewed at the DNCFM on 14 January 2019. The next meeting is on the 26 March 2019.

### NTS Charging Methodology Forum (NTSCMF) [www.gasgovernance.co.uk/ntscmf](http://www.gasgovernance.co.uk/ntscmf)

At the meeting on the 05 March 2019:

- **Pre-Modifications:** Shell highlighted that a decision on raising an Alternative to 0678 could not yet be taken due to lack of availability of analysis for 0678.
- **Forecasted Contracted Capacity (FCC) Update** - National Grid confirmed an update will be forthcoming as part of 0678 Workgroup meetings. The FCC Methodology Statement v1.0 is now available: <http://www.gasgovernance.co.uk/0678>
- **0670R - Review of the charging methodology to avoid the inefficient bypass of the NTS,** was progressed.

- National Grid confirmed the next update would be at the next meeting 02 April 2019.

### Other Workgroups

- **0678/A/B/C/D/E/F/G/H/I (Urgent) - Amendments to Gas Transmission Charging Regime.**
- Workgroup meetings began on 29 January 2019 and continued until 06 March 2019. Ofgem then decided to extend the timetable and National Grid has now provided 4 out of 5 additional documentation pieces specified by Ofgem:
  - Fully detailed FCC Methodology Statement with a governance framework
  - Final UNC678 Modification and full accompanying analysis
  - Legal text for UNC678
  - Final Sensitivity Tool for UNC678
- Ofgem requested National Grid complete a review of Existing Contracts. This has not yet been received.
- Workgroup meetings will re-commence on 25 March with further meetings on 28 March 2019, 02 April 2019 (part of NTSCMF), 04 April 2019, 08 April 2019 and the Workgroup Report will be finalised at the last Workgroup on 10 March 2019. Once the Draft Modification Report is issued for consultation on 12 March, representations can be made as usual, with consultation close out on 08 May 2019. The Final Modification Report (FMR) will be made available to Panel on 15 May 2019 for consideration at the scheduled UNC Modification Panel meeting on 23 May 2019. The FMR will then be issued to Ofgem for their ultimate consideration on 29 May 2019.

- At the meeting on 26 February 2019:
- **Pre-Modifications:** None.
- **0664 - Transfer of Sites with Low Read Submission Performance from Class 2 and 3 into Class 4.** The Workgroup noted that the amended Modification would be presented at the March meeting.
- **0672 - Incentivise Product Class 4 Read Performance.** No further progress was made with this Modification.
- The **UIG Task Force** presented a number of recommendations that they would be setting out in modifications with the aim of seeking support from industry participants to take the modification forward.

### Governance Workgroup Headlines

- At the meeting on the 08 March 2019, the main focus was finalisation of the scope for **0676R - Review of Gas Transporter Joint Office Arrangements**. The workgroup confirmed the industry could deliver the changes required and that an independent expert was not required at this stage.
- The Request Workgroup Report has now been submitted to the March 2019 Panel asking for them to note the inclusion of the scope and requests that Panel determines that the Workgroup continues.

### Committees Updates

#### Energy Balancing Credit Committee (EBCC) [www.gasgovernance.co.uk/EBCC](http://www.gasgovernance.co.uk/EBCC)

- At the meeting on 25 February 2019 Xoserve explained that previously voluntary discontinuances (when a user wanted to leave the market), had been discussed at the Energy Balancing Credit Committee (EBCC) prior to the party leaving the market and that it meant that the user had to stay in the market for another month. The Committee agreed to a change that would let the user leave the market at the time of the voluntary discontinuance request.

**AUG Sub Committee**

- At the meeting on the 15 March 2019 the key focus was to review the modified AUG Statement and the updated UIG Factors. This meeting was the last opportunity to raise any issues or concerns before the UNCC approval in April. Generally, participants were supportive of the work done by the AUGE, but some concerns were raised about the new theft methodology for 2019/20. In response, the AUGE confirmed that the new methodology better reflects theft usage and therefore is more accurate. The remaining timetable is as follows:
  - 01 April 2019 - AUGE to publish Final AUGS and Table
  - 12 April 2109 - AUGE to present Final AUGS and Table
  - 18 April 2019 - UNCC to consider Final AUGS and Table
  - Annual review of AUG process

**Data Service Contract (DSC) Committees** [www.gasgovernance.co.uk/DSC-CDSP](http://www.gasgovernance.co.uk/DSC-CDSP)

**DSC Change Management Committee** - at the 13 February meeting:

- 9 new change proposals were presented and 8 were approved, 2 change proposals were withdrawn, and 2 solution/delivery option approvals were granted.
- Updates were also provided to the Committee on the following Releases:
  - Release 3
  - February 2019 release - Minor and Major release both on track for delivery
  - June 2019 release

**DSC Contract Management Committee**

- At the meeting on the 20 February 2019, Xoserve provided updates on the Amendment Invoice Issue and open AQ issues:
  - CDSP are to produce a resolution plan with associated deliverables/dates regarding the Amendment Invoice issues/work of the AML/ASP Task Force.
  - A dedicated area has been set up on the Xoserve website for the AQ process and all the latest information on the outstanding issues would be displayed in that section.
- CDSP highlighted that the CSS Consequential Workgroups would be completed in March and the high-level design BRD's had now been produced, together with process flow diagrams. A data cleansing procedure would need to be undertaken during the detailed planning phase.

**DSC Credit Committee**

- At the 25 February 2019 meeting CDSP provided an update on the termination of Utility Professional Business Operations Ltd (UPB). Although most of the sites had now transferred over to ScottishPower, some (circa 1500) had not done so. This was still being investigated by the Customer Life Cycle Team and discussions were taking place with ScottishPower on the matter.
